

QCD Continues to Offer Tax Savings

Many people do not realize that over the past 15 months, there have been three pieces of legislation that may have an impact on how much you might pay in taxes. There is a long list of interesting changes if you are a lover of tax policy. Most people aren't.

You should consult your own advisors about whether or not there are any critical changes for what you pay and what you are planning. Here are some important points to consider.

At the end of 2019, the SECURE Act changed how your traditional or rollover IRA beneficiaries are required to pay taxes on what you have left them. It will cost them more in taxes but there are alternative strategies to reduce that tax hit. We're happy to provide more details.

There have been a lot of changes around traditional or rollover IRAs. It can be very confusing. The good news is that the Qualified Charitable Distribution (QCD) is firmly in place.

That allows you to have your IRA custodian make a direct distribution to a charity like Presbyterian Senior Living. If the amount is equal to or greater than the annual amount you are required to take out, (RMD), you don't have to take it yourself and pay taxes on it.

In the most recent stimulus bill, there was some good news for people who have big medical expenses and itemize their returns to save tax dollars. The threshold for medical deductions has been permanently lowered to 7.5% from 10% of adjusted gross income (AGI).

Who knows what tax law changes we'll be seeing in 2021? Our goal will be to keep you informed. Endowment Enhances Resident Quality of Life continued...

At the 22 affordable living communities, the introduction of ConnectedLiving University (CLU) grants made it possible for residents to learn about other places, people and cultures. Built on the belief that learning is ageless, CLU offerings touch on the five realms of living a connected life - purposeful, social, spiritual, intellectual and wellness. Programs are interactive and contain pictures, music, trivia, and discussion questions. CLU curriculum was developed with a rich understanding of the needs and interests of older adults. The programming is available online, and is easy to deliver.

For the residents of The Easton Home, an update to the "It's Never Too Late (iN2L)" programming was made possible through a grant from the endowment. iN2L is an educational tool that is used to stimulate memories, recollections, and to enhance cognitive functioning among seniors. This tool is especially valuable in working with seniors with memory impairment.

Grants Reach 140 PSL Staff

Back when the pandemic began to spread, leadership of PSL realized that there would be an impact for the staff of our numerous communities. While our concern was for the well-being of our residents, our thoughts were also about our front-line staff who were facing the virus in their everyday efforts to serve the residents of PSL.

To help meet the financial needs of our staff facing such hardships, PSL appealed to our residents, staff, Boards, families and friends for support. The Caring Community Employee Hardship Fund was established to address these needs through the provision of grants to those employees in need.

The appeal was a great success. Thanks to the generosity of our PSL family and friends we were able to raise over \$526,000 in support of our staff. To date, a total of 140 employees have benefited from the availability of this grant program. A total of \$104,000 has been distributed to those in need. Examples of what these dollars funded include: helping with rent and utilities when a lack of regular income resulted in budgetary shortfalls; childcare for those whose children were no longer able to attend school while their parents were at work; and transportation to work when public transportation was not available.

PSL is grateful to all of those who supported this very important fund. It has been a great resource to support our caregivers in a time of tremendous need.
