



403B Retirement Program Snapshot

Eligibility

Immediately as of your first day of employment.

403B Contribution

- Your total 403(b) contribution for the year cannot exceed the IRS limit – \$23,000 in 2024 (\$30,500 if you are age 50 or better). PSL employer match contributions are not part of the IRS limits
- Changes are allowed each payroll period

Match Eligibility

January 1, April 1, July 1, or October 1, following attainment of 90 days of service.

Matching Contributions

100% match on up to 4% of your 403(b) contributions.

Hardship Withdrawal

- Permitted for the following reasons:
- Medical expenses;
- Purchase of your home;
- Post-secondary education expense;
- The need to prevent eviction from your home;
- Funeral expenses; or
- Expenses to repair damages to your home caused by a natural disaster.

Vesting

100% vested - 403B and Matching.

Distributions While Employed

Age 59 ½

Loans

- Amount: Maximum 50% of your total vested account, not to exceed \$50,000 – Minimum \$1,000
- Repayment: Up to 5 years by payroll deduction
- Interest: Prime plus 1%
- Fee: \$150 deducted from your account
- Max. number of loans outstanding: 3
- Max. number of requests per year: 2

Distributions Upon Retirement or Termination of Employment

- Taxable distribution to you, less 20% tax withholding on lump sum payment (Subject to 10% penalty if you are under age 59½)
- Penalty-free and tax-free rollover to Individual Retirement Account or to another qualified plan
